Governance & Bylaws Committee Report

Chairman, Andy Flores

- Board vote on proposed amendment to Article III, Section 2:
 - Section 2. Number, Tenure, and Qualifications. A Board of Directors shall govern the Corporation. The number of persons on such Board of Directors shall consist of up to fourteen members. In addition, the Commanding Officer of the NROTC Unit or the Commanding Officer's designee shall serve as a non-voting ex officio member of the Board of Directors. Directors shall serve for a term of two calendar years. Those persons elected to succeed Directors whose terms are expiring at the end of the year shall be elected at the annual meeting of the Corporation. Directors so elected shall serve for a term of two (2) years, beginning on January 1 of the next year after the adjournment of the annual meeting at which they are elected. No member shall serve more than three (3) consecutive full terms as a Director. Only Regular Members of the Corporation shall be qualified to serve as a Director. The Board of Directors may set any financial requirement for being a Director, provided however that a member who is a serving officer may serve an additional term as an officer.



Governance & Bylaws Committee Report

- · Board vote on proposed amendment to Article V, Section 3:
 - Section 3. <u>Budget & Financial Oversight Committee</u>. This committee shall include a minimum of 3 members, including the Treasurer who serves as a nonvoting *ex officio* member. The committee shall propose a budget each year to be considered at the first meeting of the Board; in addition, the committee shall exercise oversight of the Office of the Treasurer and develop strategy and policy for the investment of long-term funds. The committee shall review (or obtain Board approval for external party review) every two years the overall investment strategy of long-term funds and provide prudent recommendations for Board consideration at the next Board meeting following the completion of the biennial review.

Chairman, Andy Flores

- Board vote on proposed addition to Article V:
 - Section 12. Naval Armory Preservation Committee. This committee shall include a minimum of 3 members. Its purpose is to advocate for and pursue opportunities and activities that ensure the long-term viability of the Naval Armory and NROTC program at UNC. This includes, but is not limited to, activities to gain historical status for the Naval Armory and surrounding area, publicize Naval contributions to the UNC community, assist in planning for and facilitating awareness events/activities, advocate for support from political, UNC faculty, NROTC Unit staff, press, and other stakeholders, and engage with and inform the Board of new developments, potential solutions, and advisable options to further the committee's mission. The Board of Directors maintains final authority on the disbursement of funds to support the Naval Armory's and NROTC program's long-term viability, based on the recommendations of the Naval Armory Preservation Committee.
- During the meeting Andy revised the proposed Amendment pertaining to the Naval Armory Preservation Committee to address concerns raised by various Board Members:
 - Section 12. Naval Armory Preservation Committee. This committee shall include a minimum of 3 members. Its purpose is to advocate for and pursue opportunities and activities that ensure the long-term viability of the Naval Armory at UNC. Additionally, as conditions change over time, this committee shall assess viable alternatives and seek directional guidance from the Board of Directors. The committee's work will include, but is not limited to, activities to gain historical status for the Naval Armory and surrounding area, publicize Naval contributions to the UNC community, assist in planning for and facilitating awareness events/activities, and advocate for support from university and external stakeholders. In addition, the committee shall engage with and inform the Board of Directors at each Board meeting of new developments, potential solutions, and advisable options to further the committee's mission. The Board of Directors shall maintain final authority on the disbursement of funds to support the Naval Armory's long-term viability based on the recommendations of this committee.
- The proposed Bylaw Amendments will be voted on by the Board by Email after the 5 day notice period required for such amendments has passed. [Motion to approve revised Bylaws approved unanimously by Board via email vote on June 30, 2023].
